 <p><b>HOUSELESS</b></p> <p>People who are living in a place not meant for human habitation.</p>	 <p><b>EMERGENCY SHELTER/ WINTER SHELTER</b></p> <p>Any facility, the primary purpose of which is to provide temporary shelter for the homeless in general or for specific populations of the homeless and which does not require occupants to sign leases or occupancy agreements.</p>	 <p><b>TRANSITIONAL HOUSING</b></p> <p>Permanent housing in which housing assistance (e.g., long-term leasing or rental assistance) and supportive services are provided to assist households with at least one member (adult or child) with a disability in achieving housing stability.</p>	 <p><b>PERMANENT SUPPORTIVE HOUSING</b></p> <p>Permanent housing in which financial housing assistance and supportive services are provided to assist households with at least one member with a disability in achieving housing stability.</p>	 <p><b>AFFORDABLE RENTAL</b></p> <p>Affordable housing is generally defined as housing on which the occupant is paying no more than 30 percent of gross income for housing costs, including utilities.</p>	 <p><b>AFFORDABLE HOME OWNERSHIP</b></p> <p>Affordable homeownership is generally defined as housing on which the occupant is paying no more than 30 percent of gross income towards the purchase of the home.</p>
